A: Answering your question, yes, this is perfectly legal, as long as you actually filed the suit. If you did not file the suit, then this is blackmail or extortion or some similar offence. It may be perfectly legal, but it's not very nice. Do you really want to be involved with someone like that? If you do actually file the suit, and don't settle it for anything reasonable, then you are no better than the blackmailer, and a judge will dismiss your suit quickly. Your letter, or the threat of your letter, is extortion, and any money that you would expect to recover from them if you do win the suit is part of the extortion. It's not extortion just to threaten to file a lawsuit, but it's extortion to threaten to file a lawsuit with any sort of motivation for the threat. Think back to prison movies, and how often the villain extorts money by threatening to "go public" with the secret information he has. It's the same thing here, as long as you do what you say you will do in the letter. In this case, you are saying you will bring a lawsuit against them, or you will threaten to do so, and they need to settle. If you don't do what you say you will

do in the letter, then you will be found in contempt of court. I should also point out that in the United States, threatening someone with prison is actually a crime. People who threaten to make murder or rape charges on others are typically charged with criminal intimidation, and 6d1f23a050
